# **ELIGIBILITY & ENTRY**

#### How to enter competitors

Entries must be submitted via <u>SEMS</u> (find SA 2023/24 Junior Carnival #4) available from Tuesday 30<sup>th</sup> January 2024.

- Club officers tasked with entering competitors for carnivals will need permission for access to SEMS (if they don't already have this) which can be requested via <a href="http://support.sls.com.au">http://support.sls.com.au</a>

#### **Entry Closing Date**

#### Entries close on SEMS at 12noon – Tuesday 6 February 2024.

Late entries will be accepted up until **12noon on Wednesday 7 February**.

# **Entry Fees**

The Junior carnival entry fee is set at **\$17.50 (GST exclusive) per entered competitor**. Any late entry (ie received after 12noon, Tuesday 6 Feb and before 12noon on Wednesday 7 Feb) will be charged at \$60 (+ GST) per late entry competitor.

Clubs will be invoiced for all entered competitors (including any late entries) following the carnival.

There will be *no charge* for the original issue of RFID wristbands used for marshalling and recording of results. **A \$10 charge** will apply to replacement bands if required.

# RFID wristband allocation will occur from 7:30am, all athletes who do not have one before the carnival please visit the admin tent adjacent to the club before entering the beach.

### Eligibility

All eligibility criteria as detailed below MUST be achieved AND showing in Surfguard by the date of the close of entries.

Award/s	Successfully have completed & recorded on Surfguard i. Junior Activities Preliminary Evaluation (specific for their current age group) AND, if wishing to participate in swim/board events/components: ii. Junior Activities Competition Skills evaluation (specific for their current age group)	
Patrol Hours	Junior members do not undertake patrolling duties	
Other	Must not be in default with their Club or SLSSA in relation to their service, financial or discipline obligations

# **ENTERING COMPETITORS INTO EVENTS IN SEMS**

All TEAM events will be split into 2 divisions. Minimum DIVISION 1 club quotas will be provided by Tuesday 30<sup>th</sup>

#### WATER SAFETY & RISK MANAGEMENT

The Safety & Emergency Committee will meet prior to the start of the carnival to determine any final procedures regarding water safety and risk management.

Should, at any stage prior to or during competition, there be a credible basis for concluding there is an unreasonable risk of serious injury occurring, the Safety & Emergency Committee and/or appropriate officials shall suspend all or parts of the competition. The Safety & Emergency Committee shall then decide whether to postpone, cancel or relocate all or parts of the competition. Should a risk assessment indicate that part, or all of the competition, not be conducted because of adverse weather or surf conditions, or another threat, the Competition and Safety and Emergency Committees will again decide whether to postpone or cancel all or parts of the competition.

#### **INFORMATION FOR FAMILIES**

#### **Sporting Environment Policy**

Any person/s found to be non-compliant with our <u>sporting environment framework</u> or code of conduct requirements may be asked to leave and clubs may be penalised points that contribute to the <u>Junior State</u> <u>Championship – Champion Club</u>. If needed, SAPOL assistance will be sought.

#### **CLUB REQUIREMENTS**

The Junior Carnival 4 Officials & Volunteer Roster is to be completed by Clubs by 12noon on Thurs 8 February. To be available from Tuesday 30<sup>th</sup> January.

#### Officials

- Club allocations as per the Officials & Volunteer Roster
- Minimum requirements for new officials prior to the carnivals
  - Completed the Officials (Core or technical) online modules including ASC (Australian Sports commission- General officiating principles
  - Current WWCC recorded in surfguard. This must be entered by the club.

#### **Photographers**

- Must have meet the requirements completed the <u>Accreditation Request Form</u> (once per photographer for the season) as per <u>C23060 Carnival Club Photographers 23-24</u>
- The number of photographers per Club is limited to a maximum of 3 at any one time.
- A maximum of 1 x photographer per Club in any competition area also applies.

#### **IRB Water Cover**

- The following clubs are rostered on to assist in the provision of IRB water safety:
  - Port Elliot x2, Glenelg x1, West Beach x1
- To provide competent crew capable of setting cans with fully equipped IRB (incl radio)

# **Shallow Water Rescue personnel**

- Competent, skilled surf swimmers (BM proficient) who would be called upon to assist should a shallow water rescue occur.
- List name/s of competent member/s who will be present at the carnival on the volunteer roster.
